

GRAND LAKES MUNICIPAL UTILITY DISTRICT NO. 4
NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District (the "Board") will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Texas 77056, said address being an official meeting place of the District.

The meeting will be held on **Wednesday, June 18, 2025, at 11:00 a.m.**

The Board shall consider and discuss the following matters and take any action necessary or appropriate with respect to such matters:

1. Public comments;
2. Review and approval of the minutes of the Board meetings of May 21, 2025;
3. Review and discussion of law enforcement services within the District, including the monthly activity reports prepared by the Fort Bend County Sheriff's Office and the Fort Bend County Precinct 1 Constable's Office, Interlocal Law Enforcement Services Agreements for sheriff and constable patrols, and Law Enforcement Services Contribution Agreement, including:
 - A. Level of service and number contract deputies;
4. Consider approval of Residential Solid Waste Collection, Disposal and Recycling Agreement between the District and Best Trash, LLC, authorize acceptance of TEC Form 1295 for same and authorize solicitation for proposals for Solid Waste Collection, Disposal and Recycling Services from Republic Services, Inc., Waste, Waste Management Inc., Texas Pride and Disposal;
5. Bookkeeper's Report, including financial and investment reports; authorize the payment of invoices presented;
6. Tax Assessor-Collector's Report, including status of delinquent taxes; authorize the payment of invoices presented, approval of tax refunds, and transfer of accounts to the uncollectible roll;
7. Discussion regarding collection and use of Strategic Partnership Agreement revenues;
8. Review of Delinquent Tax Collection Attorneys' Report from Perdue, Brandon, Fielder, Collins & Mott, L.L.P.; authorize any action necessary and appropriate in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
9. Operation and Maintenance Report, including:
 - A. Monthly report;
 - B. Appeals of District charges and other customer billing matters;
 - C. Repair and maintenance of District facilities, including consideration of any contracts for same and authorize acceptance of TEC Form 1295;
 - D. Refer accounts for collection;
 - E. Approve write-off of uncollectible accounts;
 - F. Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting

- forms as and if required, and correspondence to and from regulatory agencies regarding same;
- G. Review proposed 2025 residential and commercial rates; approval of amended Rate Order in connection with same;
 - H. Discussion of status of reclaimed water system and irrigation, including:
 - i. Status of assumption of electrical accounts for irrigation controllers from the Grand Lakes Community Association to the District;
 - ii. Status of the technology upgrades to the irrigation system; and
 - iii. Discussion of the Reclaimed Water Ground Storage Improvement Project;
10. Approval of amendments to:
- A. Waste Disposal Agreement between the District and Grand Lakes Municipal Utility Districts No. 1 and No. 2;
 - B. Water Plant Agreement between the District and Grand Lakes Municipal Utility Districts No. 1 and No. 2; and
 - C. Supplement to Amended and Restated Agreement for Joint Financing, Construction and Maintenance of Water Distribution, Sanitary Sewer Collection and Drainage Facilities (Peek and Fry Roads Repairs);
11. Discussion of Rate Order;
12. Engineer's Report, including:
- A. Authorizing the design and/or advertisement for bids for construction of facilities within the District, and approving of related storm water plans;
 - B. Review and approval of any Storm Water Pollution Prevention Plans or Storm Water Quality Management Plans related to construction within or on behalf of the District, and the execution of any documentation in connection therewith, including wastewater treatment plant site permit;
 - C. Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, approval of any related storm water permits, and authorize acceptance of TEC Form 1295;
 - D. Status of construction of facilities to serve land within the District, including the approval of any pay estimates and/or change orders and authorize acceptance of TEC Form 1295;
 - E. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes;
 - F. Status of submission of Alternate Capacity Requirements Report with the Texas Commission on Environmental Quality;
 - G. Discussion of Reclaimed Irrigation System;
 - H. Status of repair of outfall pipes; and
 - I. Submission of updated contact information and/or descriptive information regarding District facilities that qualify for critical load status to the County Office of Emergency Management, Public Utility Commission, and the Division of Emergency Management of the Governor, relative to compliance with §13.1396, Texas Water Code;
13. Request for issuance of utility commitments;
14. Request from Fort Bend County for purchase of real property;
15. District's Communications Report;

16. Discuss compliance with the EPA Phase II Small MS4 General Permit, including any training necessary under the storm water management plan;
17. Authorize completion, execution and filing with the Secretary of State of Voting System Annual Filing Form relative to District elections;
18. Attorney's Report;
19. Convene Closed Session for consultation with attorney regarding pending or threatened litigation or matters protected by attorney-client privilege pursuant to Section 551.071; as amended;
20. Reconvene in Open Session and authorize any actions related to matters discussed in Closed Session;
21. Take action on matters discussed during Closed Session; and
22. Matters for possible placement on future agendas.
